## General Information

### 1 The College

- 1.1 Maharaja's College, Ernakulam is a government arts and science college and research centre in Kerala.
- 1.2 It is administered by the Directorate of Collegiate Education under Government of Kerala, hereinafter called 'Government'.
- 1.3 The college is affiliated to the Mahatma Gandhi University, Kottayam, hereinafter called 'University'.
- 1.4 From 2014, the college is an Autonomous College as per the UGC regulations, the only such government college in Kerala. Being an autonomous college, it has its own admission process, curriculum and examination system, but the final degree certificates are issued by the university.

### 2 About This Prospectus

- 2.1 This prospectus contains general information, provisions, procedures and other connected matters relating to the admission to the first year postgraduate programmes of Maharaja's College, Ernakulam for the academic year 2026-27.
- 2.2 Provisions in any previous prospectus are not applicable for the year 2026-27.
- 2.3 The prospectus will be published on the online admission portal of the college. The prospectus will not be available in any other form including hard copy.
- 2.4 Applicants are required to go through the prospectus carefully and acquaint themselves with all the information relating to the admission procedure. They are also required to visit the admission portal (<https://maharajas.kreap.co.in>) as well as the website of the college (<http://maharajas.ac.in>) regularly for notifications, announcements and updates.
- 2.5 All communications from the college are through email and/or SMS. Applicants should enter their email address and mobile phone number during application carefully. Applicants should also access their email and SMS regularly for any communication or update from the college.
- 2.6 Notwithstanding anything contained in this document, the admission into the college shall be subject to the regulations of the university and the orders of the Government, made applicable to the college.
- 2.7 This prospectus is subject to modification, addition or deletion, as may be deemed necessary by the college. Any such changes will come into force after an order to that effect is issued.
- 2.8 Any items not specifically covered in this prospectus will be decided by the college, and such decision shall be final.
- 2.9 All disputes pertaining to the admission process shall fall within the jurisdiction of the High Court of Kerala.

3.2 All programmes are divided into four semesters completed in two years.

3.3 Applications to the lateral entry into M.A. Archaeology and Material Cultural Studies shall be submitted to the college separately (offline), and the entire process including the preparation of the rank list and allotments shall be taken up separately. Lateral admission to that programme will be strictly based on the vacancy of seats, if any, in the batch of the forthcoming seventh semester of the Integrated PG Programme in Archaeology and Material Cultural Studies.

3.4 The applicants to each programme should acquaint themselves with the structure and other details of the programme from the regulations, curriculum and syllabus published in the college website.

## **Eligibility**

### **5 Age**

- 5.1 There shall be no upper or lower age limit for admission to the postgraduate programmes. However, for admission under the sports quota, the upper age limit is 25 years.

### **6 Academic Eligibility**

- 6.1 Academic eligibility should be satisfied as on the last date for submission of online application.
- 6.2 No applicant shall be admitted to the postgraduate programmes unless he/she possesses the qualifications and minimum requirements thereof.
- 6.3 Candidates should have passed the corresponding undergraduate examination under the 10 + 2 + 3 pattern with one core/main subject and two complementary/subsidiary subjects from any of the universities in Kerala or of any university recognized by Mahatma Gandhi University as equivalent thereto for admission, subject to the stipulation regarding mark.

OR

Candidates who have passed undergraduate examination with double main or triple main subject or candidates who have passed the Degree Examination in vocational or specialized programmes are also eligible for admission. However, they have to submit copy of the equivalency/eligibility certificate from Mahatma Gandhi University, stating that, their qualifying examination is recognized for seeking admission to the relevant postgraduate programme(s) as applicable, at the time of admission. This provision is not applicable if the applicant passed the qualifying examination from Mahatma Gandhi University.

- 6.4 Applicants who have passed B.Com. (Model I, II or III), Vocational B.A./B.Sc. (Model II/III – CBCSS or Pre-CBCSS except B.A. Communicative English Model III Triple main pre-CBCSS pattern) and new-generation programmes are not eligible to apply for M.A. Arabic, M.A. English, M.A. Hindi, M.A. Malayalam or M.A. Sanskrit based on their mark obtained in Part/Common-Course-I (English) or Part/Common-Course-II (Second Language), since the content of Language & Literature of Part I and Part II of those undergraduate programmes is not sufficient enough to pursue the above postgraduate programmes.
- 6.5 The open course under the core group shall be considered only for reckoning the eligibility for applying for the postgraduate programme concerned. An applicant cannot apply for the respective postgraduate programme solely on the basis of the open course selected under the core group.
- 6.6 For each M.A. programme, 75% of the total seats shall be reserved for applicants who have graduated (i.e., the Core Course/Main under Part III of their undergraduate programme) in the same subject of the M.A. programme concerned, if those applicants are otherwise eligible.
- 6.7 For M.A. Music, two seats shall be created over and above the sanctioned strength for admitting applicants with graduation in faculties other than music. The eligibility of such applicants for M.A. Music shall be determined on the basis of the performance in an

aptitude test conducted for such applicants in the college, after the last date of submission of online application. In the aptitude test, the applicants should perform an atatalavarna, Ragalapana, Niraval and Kalpanaswara for any one of the compositions.

- 6.8 Fractions of CGPA/mark shall not be rounded up while calculating the percentage of mark to determine minimum eligibility.
- 6.9 If an applicant for admission is found to have indulged in ragging in the past or if it is noticed later that the applicant had indulged in ragging, admission shall be denied or the student shall be expelled from the college.
- 6.10 Applicants who have undergone/undergoing a UG/PG programme but not passed in all papers are not eligible for admission before passing in all papers or cancelling the exam registration.

## 8 Relaxation of Grade/Mark

- 8.1 For applicants belonging to Scheduled Caste or Scheduled Tribe of Kerala, the minimum grade in the qualifying examination shall be a pass in the qualifying examination.
- 8.2 For applicants belonging to SEBC, there shall be a relaxation of 3% mark in the qualifying examination from the prescribed minimum. Hence the minimum grade/mark for M.Sc. programmes shall be CGPA/CCPA of 47% of the maximum CGPA/CCPA for CBCSS Grading patterns, and 47% mark in pre-CBCSS patterns. For admission to M.A./M.Com. programmes, the minimum grade/mark shall be CGPA/CCPA of 42% of the maximum CGPA/CCPA for CBCSS Grading patterns, and 42% mark in pre-CBCSS patterns.
- 8.3 For applicants belonging to OEC, there shall be a relaxation of 5% mark in the qualifying examination from the prescribed minimum. Hence the minimum grade/mark for M.Sc. programmes shall be CGPA/CCPA of 45% of the maximum CGPA/CCPA for CBCSS Grading patterns, and 45% mark in pre-CBCSS patterns. For admission to M.A./M.Com. programmes, the minimum grade/mark shall be CGPA/CCPA 40% of the maximum CGPA/CCPA for CBCSS Grading patterns, and 40% mark in pre-CBCSS patterns.
- 8.4 For the differently abled applicants there shall be a relaxation of 5% mark in the qualifying examination from the prescribed minimum. Hence the minimum grade/mark for M.Sc. Programmes shall be CGPA/CCPA of 45% of the maximum CGPA/CCPA in CBCSS

Grading patterns, and 45% mark in pre-CBCSS patterns. For admission to M.A./M.Com. programmes, the minimum grade/mark shall be CGPA/CCPA 40% of the maximum CGPA/CCPA in CBCSS Grading patters, and 40% mark in pre-CBCSS patterns.

## Seats and Reservation Quotas

### 9 Classification of Seats and Reservation Quotas

9.1 The seats available in postgraduate programmes are classified/reserved as under:

- A. Special Reservation Seats
  - A.1 Sports Quota
  - A.2 Cultural Quota
- B. General Merit Seats
  - B.1 Open Quota
  - B.2 Socially and Educationally Backward Classes Quota
    - i. Ezhava
    - ii. Muslim
    - iii. Other Backward Hindus
    - iv. Latin Catholic other than Anglo-Indians
    - v. Other Backward Christians
  - B.3 Scheduled Castes Quota
  - B.4 Scheduled Tribes Quota
  - B.5 Economically Weaker Sections Quota
- C. Seats for Persons with Disabilities
- D. Seats for Nominees from Lakshadweep
- E. Seats for Transgender Persons

### 10 Sports Quota (Special Reservation)

- 10.1 One seat for every 20 seats for M.A., M.Sc., M.Com. Programmes with permission for interchangeability shall be reserved for admission under the sports quota.
- 10.2 Where the number of seats is less than 20 for a programme, the seats may be pooled together, M.A., M.Sc., and M.Com. being treated separately. Where the number of seats, after pooling, exceeds multiples of 20, one additional seat can be earmarked, if the excess is 15 or more. Where the number of seats is less than 15 after such pooling, all postgraduate programmes may be pooled together. After such pooling, if the number of seats exceeds multiples of 20, an additional seat can be earmarked if the excess is 15 or more. A minimum of one seat may be given if there are no sufficient seats.
- 10.3 The applicants should have represented at least the college in the intercollegiate competitions. Applicants who have represented the State/University shall be preferred to applicants who have represented the District/College. Performance in any year during the undergraduate programme only will be taken into consideration.
- 10.4 The guidelines to determine the merit in sports and games for admission under sports quota shall be as given in **Appendix I**.

### 11 Cultural Quota (Special Reservation)

- 11.1 One seat for every 20 seats for M.A., M.Sc., M.Com. Programmes with permission for interchangeability shall be reserved for admission under the cultural quota.
- 11.2 Where the number of seats is less than 20 for a programme, the seats may be pooled together, M.A., M.Sc., and M.Com. being treated separately. Where the number of seats, after pooling, exceeds multiples of 20, an additional seat can be earmarked, if the excess

is 15 or more. Where the number of seats is still less than 15 after such pooling, all postgraduate programmes may be pooled together. After such pooling, if the number of seats exceeds multiples of 20, an additional seat can be earmarked if the excess is 15 or more. A minimum of one seat may be given if there are no sufficient seats.

- 11.3 The selection shall be made from among the applicants for the cultural quota on merit as per the criteria given in **Appendix II**.

## 12 General Merit Seats

- 12.1 Leaving the seats set apart for special reservation, the remaining seats for each programme are General Merit seats, which shall be distributed as given below:

- 12.1 The seat reservation shall be in accordance with the provisions contained in relevant orders of Government of Kerala issued or amended from time to time.
- 12.2 Claim for seat reservation must be made by applicants at the time of submission of application. The claim for reservation once made cannot be altered later by the applicant under any circumstances.

## 13 Open Quota

- 13.1 All applicants included in the rank lists are eligible for admission under the Open Quota. Applicants may be eligible for admission under other reservation quotas also (SEBC, SC, ST or EWS). An applicant eligible for admission under the open quota will be admitted under the open quota, even if the applicant may be eligible under another quota of the same programme. An applicant not eligible for SEBC, SC, ST or EWS reservation will be considered against the open quota.

## 14 Socially and Educationally Backward Classes (SEBC) Quota

- 14.1 Twenty percent of the General Merit seats are reserved for applicants belonging to Socially and Educationally Backward Classes (SEBC) of Kerala. Applicants belonging to SEBC as per G.O. (P) 208/1966/Edn dated 02.05.1966, amended from time to time, only are eligible for reservation under this category. The seats are distributed among different communities as provided in G.O. (MS) 107/2008/HEDN dated 30.08.2008.
- 14.2 Applicants satisfying the Non Creamy Layer criteria only are eligible for claiming reservation under SEBC category (G.O. (P) 02/2017/BCDD dated 08.03.2017). Applicants

claiming reservation under SEBC should produce valid community/caste certificate and also the non-creamy layer certificate issued by the competent authority of Revenue Department (Village Officer or above) at the time of admission. The validity of Non Creamy Layer certificate is one year from the date of issue.

- 14.3 The list of communities eligible for claiming admission under SEBC is given in **Appendix III**. Only the claims of the applicants belonging to the communities in the list will be considered.

## **15 Economically Weaker Sections Quota**

- 15.1 Ten percent of General Merit seats are reserved for the Economically Weaker Sections (EWS) who are not covered under other schemes of reservation (SC/ST/SEBC). Applicants claiming reservation under EWS quota should produce the relevant 'Income & Assets Certificate' or the '*Anthyodaya Anna Yojana (AAY) and Priority House Hold (PHH) Category*' certificate from the revenue authority concerned at the time of admission. (GO (MS) No. 128/2020/HEDN dated 20/03/2020).

## **16 Scheduled Castes Quota**

- 16.1 Fifteen percent of the General Merit seats are reserved for applicants belonging to Scheduled Castes of Kerala. Applicants claiming reservation under Scheduled Castes quota should produce valid community/caste certificate obtained from the revenue authority concerned at the time of admission.
- 16.2 The list of communities eligible for claiming admission under Scheduled Castes quota is given in **Appendix IV**. Only the claims of the applicants belonging to the communities in the list will be considered.

## **17 Scheduled Tribes Quota**

- 17.1 Five percent of the General Merit seats are reserved for applicants belonging to Scheduled Tribes of Kerala. Applicants claiming reservation under Scheduled Tribes quota should produce valid community/caste certificate obtained from the revenue authority concerned at the time of admission.
- 17.2 The list of communities eligible for claiming admission under Scheduled Tribes quota is given in **Appendix V**. Only the claims of the applicants belonging to the communities in the list will be considered.

## **18 Seats for Persons with Disabilities**

- 18.1 Five percent seats shall be created over and above the sanctioned strength in all programmes exclusively for applicants with benchmark disability (as per clause 32 (1) of chapter VI, The Rights of Persons with Disabilities Act, 2016).
- 18.2 Persons with Disabilities means a person suffering from not less than 40% of any disability as certified by a Medical Board constituted for this purpose. Applicants who have a minimum of 40% disability alone will be eligible for this quota. A relaxation of 5% mark in the qualifying examination from the prescribed minimum is allowed.
- 18.3 Applicants seeking admission under Persons with Disabilities category should submit the 'Certificate of Disability', issued not earlier than 5 years prior to the submission of application, by the District Medical Board or bodies of higher status, certifying percentage of disability. The 'Certificate of disability' should be uploaded along with the online

application. Based on the details furnished in the online application, applicants will be provisionally included under the Persons with Disabilities category.

18.4 The selection of applicants under this category will be based on the rank in the inter-merit list and not on the basis of the degree of disability.

18.5 No reservation of seats is allowed for blind applicants for the M.Sc. programmes.

#### **19 Seats for Nominees from UT of Lakshadweep**

19.1 An additional seat shall be created in each programme exclusively for the purpose of admitting applicants sponsored by the Union Territory of Lakshadweep. Applicants to this quota should produce the nomination letter from the competent authority of the Union Territory of Lakshadweep.

#### **20 Seats for Transgender Persons**

20.1 Two seats shall be created over and above the sanctioned strength in all programmes exclusively for admitting transgender applicants (G.O. (MS) 153/2018/HEDN dated 03.07.2018).

#### **21 Seats Not Availed under Reservation**

21.1 The seats not availed by eligible applicants under the Sports Quota shall be merged into the General Merit seats of the programme.

21.2 The seats not availed by eligible applicants under the Cultural Quota shall be merged into the General Merit seats of the programme.

21.3 The seats not availed by eligible applicants under the SEBC Quota shall be allotted under the Open Quota of the programme.

21.4 The seats not availed by eligible applicants under the EWS Quota shall be allotted under the Open Quota of the programme.

21.5 If sufficient applicants are not available for filling the seats reserved for Persons with Disabilities, Nominees from Lakshadweep, and Transgender Persons, such seats shall not be filled from any other categories.

#### **22 Seats Not Availed by SC/ST applicants**

22.1 The seats unavailed by the SC candidates will go to ST candidates and vice versa. The unavailed seats reserved for SC/ST shall be re-notified through print media and a special allotment shall be conducted exclusively for filling up vacant seats of SC/ST candidates. If such seats are remaining vacant even after re-notification, these shall be filled up from candidates belonging to OEC.

22.2 The OEC (SC) and OEC (ST) applicants who claim allotment under SC and ST quota respectively as above, should furnish community/caste certificate obtained from the revenue authority concerned at the time of admission.

22.3 In addition to the above, applicants belonging to OEC (SC) and OEC (ST) are eligible for educational concessions available for SC and ST communities, irrespective of their family income. They should provide caste/community certificate from the competent authority at the time of admission for availing the concessions (See Clause 43.2).

22.4 The list of communities belonging to OEC (SC) is given in **Appendix VI**, and the list of communities belonging to OEC (ST) is given in **Appendix VII**. Only the claims of the applicants belonging to the communities in the list will be considered.

## Application Process

### 23 Online Application

- 23.1 The application process for admission to all the postgraduate programmes is fully online for all categories of applicants, except for the applicants for the lateral entry into M.A. Archaeology and Material Cultural Studies. Online application should be made from the admission portal (<https://maharajas.kreap.co.in>) of the college. Applicants to the lateral entry into M.A. Archaeology and Material Cultural Studies shall submit separate physical application form available at the college office before the last date notified, along with the required documents.
- 23.2 Only one online application can be submitted by an applicant. Application to all eligible programmes (subject to a specified maximum) can be made in the single online application. Applicants to the lateral entry into M.A. Archaeology and Material Cultural Studies, may submit one online application in addition to the offline application.
- 23.3 All categories of applicants should register and apply online, and upload the required documents online.

### 24 Registration and Application Form

- 24.1 Before submitting the application, all applicants should register in the online portal. For registration, the email address, mobile phone number, category and the minimum basic details of the applicant should be provided. Since all communications from the college shall be through email or SMS, the applicants should enter their email and mobile phone number very carefully, and regularly check their email and SMS for any communication from the college.
- 24.2 After successful registration, and logging in, the other basic personal and academic details of the applicant need to be entered to create the profile of the applicant.
- 24.3 All applicants are required to upload the soft copy of the consolidated mark sheet/ grade sheet. Applicants have to upload a recent photograph, signature and other required documents also.

### 25 Order of Preference

- 25.1 Applicants can choose the programmes which they are applying. Applicants can choose a maximum of three eligible programmes as per their preference. Applicants should choose the programmes as well as the order of preference carefully. Admission to the programmes will be based on the preference order.

### 26 Application Fee

- 26.1 An application fee at the following rates shall be paid online by the applicant to complete the registration process. Applicants to the lateral entry into M.A. Archaeology and Material Cultural Studies shall pay the application fee at college office.

Application fee for Scheduled Castes or Scheduled Tribes:	Rs. 200
Application fee for all other applicants:	Rs. 400

- 26.2 The application fee once remitted shall not be refunded under any circumstances.

### 27 Submission of Application

- 27.1 Claims that are not mentioned at the time of submission of application will not be considered under any circumstances, even if supporting evidences are produced later on.

- 27.2 Any kind of false information may lead to cancellation of admission at any stage.
- 27.3 Before submitting, the applicants should verify the details and the order of programmes preferred furnished. After verification, the application can be submitted.
- 27.4 Upon successful final submission and online payment of application fee, an application form will be generated containing the fee payment details. The printout of the application form (with application number) should be kept by the applicants, and should be submitted at the time of admission along with other documents.
- 27.5 The printout of the online application shall not be sent to the college.

## **Index mark and Rank List**

### **28 Index Mark**

- 28.1 At the close of the application, index mark of all the applicants will be calculated for preparing the rank list.
- 28.2 For preparing the rank list of applicants qualified under CBCSS (direct grading or indirect grading), the CGPA/CCPA secured for Part III Core group (Core + Complementary courses) shall be converted into mark out of 1000, unless otherwise mentioned. For preparing the rank list of applicants qualified under Pre-CBCSS pattern, the mark obtained in the qualifying examination in Part III subjects shall be standardized into mark out of 1000, unless otherwise mentioned.
- 28.3 Wherever letter grade is given for the qualifying examination, the applicant should produce the relevant conversion document so that the grade can be converted into mark out of 1000. In the case of grade where mark range is given, the mid value will be taken for computation of index mark.
- 28.4 Once the relevant mark of the qualifying examination is converted as above, weightage mark and bonus mark are added and negative mark are deducted to arrive at the index mark.

### **29 Weightage Mark**

- 29.1 For M.A. Arabic, weightage of 20% marks shall be given to the applicants who have studied Arabic as core papers/main after standardizing the marks secured for the same to 600.
- 29.2 For M.A. English, weightage of 20% marks shall be given to the applicants who have studied conventional English Language and Literature as core papers/main after standardizing the marks secured for the same to 600. Weightage of 10% mark shall be given to the applicants who have studied non-conventional courses in English Language as core course/main after standardizing the mark secured for the same to 600.
- 29.3 For M.A. Hindi, weightage of 20% mark shall be given to the applicants who have studied conventional Hindi Language and Literature as core papers/main after standardizing the mark secured for the same to 600. Weightage of 10% mark shall be given to the applicants who have studied non-conventional courses in Hindi Language as core papers /main after standardizing the mark secured for the same to 600.
- 29.4 For M.A. Malayalam, weightage of 20% mark shall be given to the applicants who have studied conventional Malayalam Language and Literature as core papers/main after standardizing the mark secured for the same to 600. Weightage of 10% mark shall be given to the applicants who have studied non-conventional courses in Malayalam Language as core papers/main after standardizing the mark secured for the same to 600.
- 29.5 For M.A. Sanskrit (General), weightage of 20% mark shall be add given to the applicants who have studied Sanskrit Language (General) as core papers/main after standardizing the mark secured for the same to 600. Weightage of 10% mark shall be given to the applicants who have studied Sanskrit Language (with specialization) as core papers/main after standardizing the mark secured for the same to 600.
- 29.6 For M.A. Economics, weightage of 10 marks shall be given to the applicants who have

studied Economics as optional.

- 29.7 For M.A. History, weightage of 10 marks shall be given to the applicants who have studied History as optional.
- 29.8 For M.A. Islamic History, weightage of 10 marks shall be given to the applicants who have studied Islamic History as optional.
- 29.9 For M.A. Philosophy, weightage of 10 marks shall be given to the applicants who have studied Philosophy as optional.
- 29.10 For M.A. Political Science, weightage of 5 marks to be given to the applicants who have studied any of the papers namely Politics, Political Science, Political Theory, Political Philosophy as Part III main/subsidiary/elective/allied/complementary of B.A. Degree examination. Weightage of 10 marks shall be given to the applicants who have studied Politics as optional.
- 29.11 For M.A. Archaeology and Material Cultural Studies, weightage of 10 marks shall be given to the applicants who have studied Archaeology as optional.

### **30 Bonus Mark**

- 30.1 A bonus of 10 marks shall be added while calculating the index mark of NCC 'B' or 'C' Certificate holders. The NCC certificates should be signed by the Director and issued by the Directorate provided the candidates have secured at least 75% attendance after having participated in NCC activities during the period of study for Undergraduate programmes.
- 30.2 A bonus of 5 marks shall be added while calculating the index mark of applicants with NSS certificates signed by the Vice-chancellor or the Pro-Vice-chancellor and issued to volunteers who have completed 240 hours of work within a period of 2 years of the qualifying undergraduate study immediately preceding the postgraduate programmes for which admission sought.
- 30.3 The benefit of bonus mark can be claimed by an applicant under one category only i.e.; either NSS or NCC.
- 30.4 A bonus of 15 marks shall be added while calculating the index mark of ex-servicemen applicants and widows and children of Jawans and ex-service men seeking admission to the postgraduate programmes. Applicants in this category should invariably produce the certificate in support of their claim at the time of admission. The certificate should be obtained not earlier than six months from the last date of submission of application from the military authorities or state/Zilla Sainik Welfare Officer to the effect that the applicant is the son/daughter of ex- service man or an ex-service man himself/herself. The certificate should clearly show that the benefit of reservation has not been granted earlier to any member in the family. In the absence of the above certificate the claim will not be considered.
- 30.5 Bonus mark will be added only if the applicant has obtained the prescribed minimum qualifying mark in the qualifying examination.
- 30.6 The applicants claiming any bonus mark should produce the certificate concerned in original at the time of admission for verification.

### **31 Negative Mark**

31.1 Deduction will be made from the total ranking marks for those candidates who had availed more than one chance in passing the qualifying examination. While calculating the index mark, five mark each shall be deducted for each additional appearance taken for completing the qualifying examination. Number of chances means the number of chances for passing any part of the qualifying examination excluding cancellation.

### **32 Index Calculation for M.A. English**

32.1 The CGPA/CCPA of eligible applicants graduated under CBCSS pattern in Model I English, shall be converted into mark in 1000 as follows: CGPA/CCPA secured for Common Courses or Core courses, whichever is higher, is multiplied by  $\frac{1000}{\text{Maximum CGPA}}$ . For eligible applicants graduated under pre-CBCSS patterns in Model I English, the mark secured for Part I English or Part III Main, whichever is higher is converted into 1000.

32.2 The CGPA/CCPA of eligible applicants graduated under CBCSS pattern in Model II/III English, shall be converted into mark in 1000 as follows: CGPA/CCPA secured for Core courses is multiplied by  $\frac{1000}{\text{Maximum CGPA}}$ . For eligible applicants graduated under pre-CBCSS patterns in Model II/III English, the mark secured for Part III Main/core English is converted into 1000.

32.3 The CGPA/CCPA of eligible applicants graduated under CBCSS pattern in other disciplines (i.e., graduation in other Languages, Social Science, Science or Oriental Studies), shall be converted into mark in 1000 as follows: CGPA/CCPA secured for Part I Common course (English) is multiplied by  $\frac{1000}{\text{Maximum CGPA}}$ . For eligible applicants graduated under pre-CBCSS patterns in other disciplines (i.e., graduation in other Languages, Social Science, Science or Oriental Studies), their mark for Part I English is converted into 1000.

32.4 The Index mark is arrived at by adding the weightage mark and bonus mark, and deducting negative mark, if any, to the relevant mark as converted above.

### **33 Index Calculation for M.A. in Other Languages (Arabic, Hindi, Malayalam or Sanskrit)**

33.1 For the calculation of index marks, the percentage of marks obtained under part II common papers/Additional language or percentage of marks under part III core courses /main papers whichever is higher in the case of those who have taken the language concerned as optional under Part III for the BA Programmes/courses; and in the case of other graduates of B.A./B.Sc., the grades/marks scored under part II of the courses/papers concerned are taken in to account, as follows.

33.2 The CGPA/CCPA secured under the CBCSS pattern for part III/Part II Common Papers, as the case may be, is converted into marks in 1000 by multiplying the same by  $\frac{1000}{\text{Maximum CGPA}}$ . For eligible applicants who graduated under pre-CBCSS patterns, the mark secured for Part III Main/Part II Addl. Language is converted into 1000.

33.3 The Index mark is arrived at by adding the weightage mark and bonus mark, and deducting negative mark, if any, to the relevant mark as converted above.

### **34 Index Calculation for M.A. (Social Sciences) / M.A. Music / M.Sc. Programmes**

34.1 For M.A. in social sciences (Economics, History, Islamic History, Philosophy and Political Science), M.A. Music and all M.Sc. programmes, CGPA/CCPA for Part III Core +

Complementary courses is taken into account for the calculation of index mark as below:

### **Applicants with B.Com. Model II/Model III – pre-CBCSS Pattern:**

In the case of applicants who have passed B.Com. Model II, mark secured for part III Core Papers is converted into 1000. In the case of applicants who have passed BBA, total mark obtained excluding the mark of English, Social Project, Management Project, Viva shall be converted to 1000. In the case of applicants who have passed BBM, total mark obtained excluding the mark of English, Industrial training and Project report and Comprehensive Viva-voce shall be converted to 1000. The Index mark is arrived at by adding the weightage mark and bonus mark and deducting negative mark, if any, to the relevant mark as converted above.

### **36 Tie-breaking Principles**

- 36.1 In case more than one applicant obtaining equal index mark for a programme (after adding weightage/bonus mark and deducting negative mark, if applicable), the following tie-breaking principles shall be applied one after another in the given order:
  - 36.1.1 The applicant with higher mark in Part III core shall be placed higher in ranking.
  - 36.1.2 The applicant with higher mark in Part I common courses (English) shall be placed higher in ranking.
  - 36.1.3 The applicant with higher mark in Part II common course (additional language) shall be placed higher in ranking.
  - 36.1.4 the age of the applicants will be taken into account, the older being placed higher in the ranking.
  - 36.1.5 If the tie persists, the alphabetical order of the first name of the candidates will be taken into account.
  - 36.1.6 The applicant who generated the application number first shall be placed higher in ranking.

### **37 Draft Eligibility List**

- 37.1 At the close of the application, a draft eligibility list for all programmes will be published in the admission portal on the basis of index marks, for verification by the applicants.

### **38 Rank List**

- 38.1 The final rank list of each programme will be published online.

## **Admission Process**

### **39 Reporting for Admission**

- 39.1 After publication of the rank list, applicants to each programme, fully or partially, will be intimated to report for admission in the college.
- 39.2 The intimation to report for admission does not necessarily ensure admission; admission shall be subject to availability of seats, physical verification of documents for eligibility, other claims, and payment of required fees.
- 39.3 Those who fail to report at the specified date and time will lose their claim for admission.
- 39.4 When vacancies arise in a programme at a later stage, and all reported students are admitted, further intimations will be sent to the remaining applicants in the rank list. Therefore, those who do not receive intimations in the first stages may wait for their turn until admissions are over.

### **40 Verification of Documents**

- 40.1 At the time of admission, applicants have to produce all certificates/documents required to prove their claims in the application, and pay the fees.
- 40.2 The Head of the Department concerned shall verify the correctness of the records produced by the applicant at the time of admission.

### **41 Cancellation of Preferences**

- 41.1 With admission to a programme, all the preferences lower than the admitted one will automatically be removed from the preference list of the applicant. For example, if an applicant had registered 3 preferences in all, and is admitted in the 2nd preferred programme, then the 3rd preferred programme will be automatically removed. The first preferred programme will remain valid and will be considered in future admissions.
- 41.2 If an applicant who is admitted to a lower preference programme does not want to be considered for further allotments in higher preferred programmes, the applicant may cancel the remaining higher preferences, fully or partially, at the time of admission. If not cancelled, the applicant will be considered in further allotments. For example, if an applicant is allotted the 3rd preferred programme, and the applicant does not want admission in the 2nd preferred programme, he/she may cancel preference 2, but retain preference 1. Preference 1 will remain valid and will be considered for future allotments.
- 41.3 An applicant retaining any of the higher preferences after admission, is bound to accept the new admission in the that preference, if received. In the event of the new admission, the previous admission will be automatically cancelled.
- 41.4 A student first admitted in a programme against Sports Quota, Cultural Quota, Seat for Persons with Disabilities, Seat for Nominees from Lakshadweep, or Seat for Transgender Persons, shall not be included in further allotments under SC/ST/SEBC/EWS quota, if applicable, of the same programme. However, such applicants shall be considered for allotment under the open quota of the same programme, and also in allotments to the retained higher preferences, if any, under any quota.

## Fees

### 42 Types

- 42.1 In addition to the application fee collected at the time of online registration, the college collects various fees during the time of admission.
- 42.2 Fee for various programmes will be decided by the State Government and the amount given in this prospectus is subject to changes.

### 43 Fee Concessions

- 43.1 Applicants belonging to the following categories are exempted from payment of various fees irrespective of the quota against which they are admitted.

SC	Income certificate is not required.
ST	Income certificate is not required.
OEC (SC)	Income certificate is not required.
OEC (ST)	Income certificate is not required.
The 30 OBH Communities made Eligible for OEC Concessions ( <b>Appendix VIII</b> )	Income certificate is required for fee concession. Annual income should not be more than Rs 6 lakh.
Any other applicant including those do not come under any schemes of reservation (KPCR)	Income certificate is required for fee concession. Annual income should not be more than Rs 1 lakh.

- 43.2 Applicants belonging to SC, ST, OEC (SC) and OEC (ST) are excepted from such fee payment irrespective of the annual income. Those applicants should submit valid caste/community certificate from the competent authority at the time of admission for availing the concessions.
- 43.3 The educational concessions available for the OEC (SC/ST) are applicable to 30 OBH communities also, provided the annual income is not more than Rs 6 lakh (G.O. (MS) 10/2014/BCDD dated 23.05.2014 and G.O. (MS) 7/2016/BCDD dated 25.08.2016). But applicants belonging to those 30 communities are not eligible for admission against the un-availed seats of SC or ST Quota as available for OEC (SC/ST) as per G.O. (MS) 14/2017/BCDD dated 02.08.2017. For availing the concessions, the applicants should produce community certificate as well as income certificate as above at the time of admission. The list of the 30 communities is given in **Appendix VIII**.
- 43.4 Any other applicant can claim educational concessions as per the Kumara Pillai Commission Report (KPCR), if the annual income is not more than Rs 1 lakh (G.O. (MS) 6/2014/BCDD dated 21.02.2014 and G.O. (MS) 15/2014/BCDD dated 08.08.2014). For availing the concessions, applicants should produce income certificate as above at the time of admission. However, Special Fee, Caution Deposit, CDC Fund and PTA Fund are collected from these applicants.
- 43.5 SC/ST/OEC candidates will have to pay the 'Caution Deposit' as per rules.
- 43.6 The amount towards the CDC fund and PTA fund will be as per the rates decided by the respective committees.
- 43.7 Amounts of various fee components for the first year of the undergraduate/integrated programmes, payable at the time admission, are given in **Appendix IX**.

- iv. Where still bracketed, Priority will be given in the order of merit i.e.; 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place respectively.
- v. Those with a greater number of achievements in the same level will be placed above the others (a greater number of 1st places, a greater number of 2nd places and so on).
- vi. Individual achievements will be ranked above team achievements.
- vii. A new record is created; he/she will be given priority.
- viii. If the tie could not be resolved by any of the above-mentioned sports achievements, the index marks based on the qualifying examination shall be considered for breaking the tie.
- ix. Performance in any year during the Under Graduate programme will be taken into consideration.
- x. The students admitted in Sports quota shall mandatorily be available to represent the college in the Inter University competitions unless specifically exempted by the Principal.
1. Only the events, which are having intercollegiate competitions in Mahatma Gandhi University alone, will be considered for Sports Quota admissions.

- 2 Approved World competitions means the competitions organized by the International Apex Bodies of the concerned discipline and in which the national Teams are sponsored by the National Apex Bodies and cleared by Sports Authority of India/ Government of India .
- 3 The National Championship means the championships conducted by the National Apex Bodies of the concerned discipline. District Competition means revenue district competition conducted by district association in respective sports.
- 4 Individual games /event means a game/event in which individual performs alone.
- 5 When a candidates has number of achievement in a sports /different discipline his/ her best achievement will be taken in to consideration.
